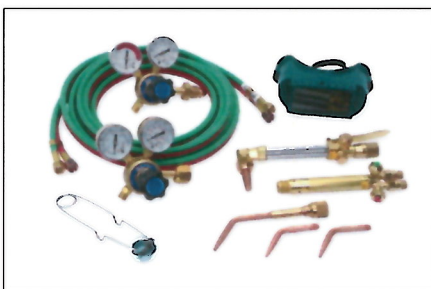
Torch Kits and Handles manufactured by Harris Products between December 1, 2013 and May 31, 2014.

Models 18-5 and 85, Sold between December 2013 and May 2014

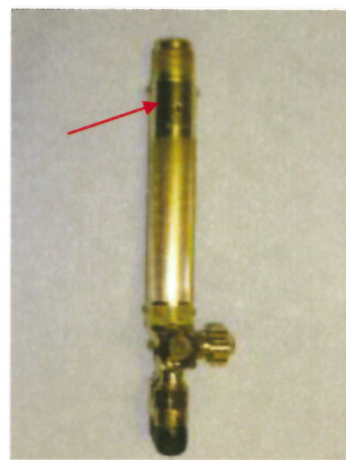

(Units with "O" above "Harris" and to the right of the rivet head are not included in this recall.)

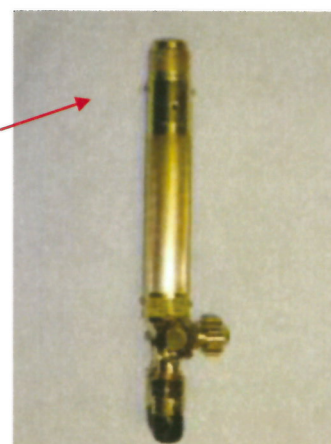

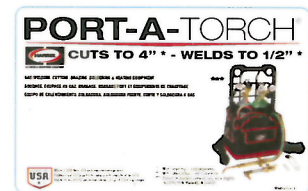

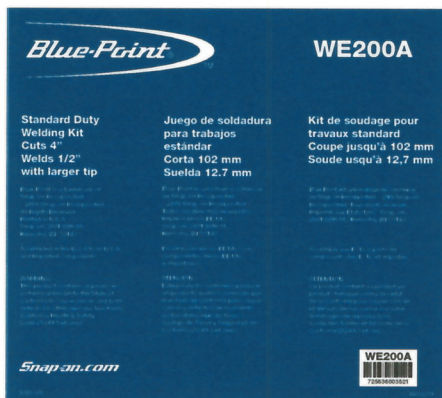
