PART NAME & DESCRIPTION:

Automotive Lift used for General Service and Vehicle Alignment Open Front 4-Post Lifts - 172" and/or 210" Wheelbase capabilities, with 24" wide runways.

HAZARD:

During raising or lowering of the lift, the threaded cylinder piston rod end may fracture, causing the lift to suddenly drop. This may cause serious personal injury or death.

ACTIONS:

Snap-on Equipment is voluntarily replacing hydraulic cylinders used in production of open front 4-Post lifts manufactured from 1997 to 2008.



Either of these Serial Number / Model Number tags may have been applied to your lift. Either tag would be located in an area on the side of the drive runway near the turn plate cutout as shown in figure 1.

Tag 1 shown below used on older lifts.



Tag 2 shown above used on more current lifts, date of manufacture was included in the serial number code, used separate, additional tags for voltage requirements and WARNING.
